The Tenderer should fulfill the following criteria:

- A. **Affidavit regarding correctness of bid.** (As per format attached in tender document)
- B. Valid Certificate as a registered contractor in appropriate class with Public Works Department (Class-4 & Above).
- C. **GST registration** Certificate.
- D. **Professional tax** registration.
- E. Permanent Account Number (PAN).
- F. Valid original latest Solvency certificate of amount Rs. 145.20 lakh from any nationalized / scheduled / scheduled commercial bank.
- G. Income Tax returns photocopy duly self-attested for income tax returns for the Financial Years of 2014-15, 2015-16 & 2016-17.
- H. Average annual financial turnover certificate from Chartered Account during the last 3 Financial Years (2014-15, 2015-16 & 2016-17), ending 31st March of the previous financial year, should be **Rs.300.00 Lakhs**.
- Experience of having successfully completed similar type of works during last 7 years ending last day of month previous to the one in which applications are invited should be either of the following: (Please attach Work Done certificates).
 - i. Three similar completed works costing not less than the amount equal to 40% of the estimated cost. OR
 - ii. $\,$ Two similar completed works costing not less than the amount equal to 50% of the estimated cost. 0R
 - iii. One similar completed work costing not less than the amount equal to 80% of the estimated cost.
- J. **Form No. I to Form No. V** (As per format attached herewith in tender document).
- K. **Affidavit as per format on Rs. 100/- stamp paper.** (As per format attached in tender document)
- L. Attested copy of registered partnership deed or Memorandum of Articles of Association, if the tenderer is a partnership firm or Joint Stock Company as the case may be and Power of Attorney.
